Treasurer's Report	Janie N reported a balance of \$32,980.10 in the MCC account. This does not include the \$847.81 that was made at the McDonald Fundraiser. The expense for the month included the subscription fee for Zoom. November Budget Report  Condee asked Janie what process she would like to use so that teachers can be reimbursed when they use their allocated funds. Janwants teachers to scan and email a receipt so that teachers can be reimbursed. Janie will send reimbursement checks to teachers via mail. Janie is donating the stamps. Amanda brought up that MCC reimbursement forms can be found online. Amanda suggested Janie buy a book of stamps with MCC funds.		
Principal's Report	Condee reported that she sent out an email regarding Veterans Day; Events have been created in an asynchronous format used during the Advisory classes this week;  Update on in-person learning: most recent guidelines, from Dr. A is that all hybrid learning remains on-hold until January. For secondary schools that will be February. Hybrid would be an A/B schedule. Only if the transmission rate is down. We have had 15 of our DLC students on campus since the end of September with no incidents. Monday-Friday in the morning.		

On Tuesday, our ELL students along with Melissa Wood and Amanda Yonker will be coming in for in-person learning. There will be two groups of 10 students. They will come 3 days a week;

The office will be locked, and front doors are locked but people can call the office number from outside the doors during office hours.

Michele and Condee have been tracking closely students who are struggling. Our teachers are working really hard with kids but it's difficult when kids aren't participating. We have reached out to families to provide help, but there are circumstances where it is hard to get kids to engage. We may have some of these kids in small groups of 5 coming in possibly 1-2 days per week.

Marshall has had a thriving active Equity Group. 13 staff members went through about 20 hours of training during the summer. These staff members are working to provide opportunities for teachers to talk about equity in the classrooms. Eventually, the plan is to reach out to get community members involved as well in these meetings. Condee has talked with McLane and Hansen about working together on this.

Michele reports that we have started Lunch Bunch Groups. Kids were surveyed a few weeks ago about their interests. The greatest interest is in video game chats, Among Us game, Art and music. Kids can attend lunch bunch groups by going to the MMS website and click on Zoom link. Once they are in the group, they will choose which topic they'd like and will go to the breakout room with other students and with paras. We did a "soft" opening this week. The Bridge Music Project is underway on Wednesdays from 12:15-1:30. 23 kids are participating. Mrs. McBride, our new counselor plans to start a lunch bunch group soon. It likely will be for new students who are interested in chatting with other new students.

MAP testing started last week. Reading test was on Nov. 4. Math test will be on Nov. 18. Testing occurs in Advisory classes. Several dates are scheduled for kids who either need to finish up their test or for kids who didn't originally take the tests. Overall, testing appears to be going well. Kids (and teachers) are able to navigate the testing site and Zoom at the same time with success.

- Thanksgiving Plans Condee reports that we have 29 requests for Thanksgiving Dinners; The volunteer that donated last year is able to provide 50 dinners this year for Thanksgiving. Amy Long is looking into Sign-up Genius. Condee will send Amy the requests so that Amy can have it ready to send out after it closes on Dec. 4th.
